This housing agreement is for students living in University residence halls and houses. The agreement is effective for the fall, spring, and summer sessions of the same academic year. The fees for University housing will be published in the "Student's Statement of Charges" supplement to the Campbell University Bulletin. **This constitutes acceptance by the student of housing space, not a particular room.** Residence halls are segregated by gender.

Terms, Conditions, and Responsibilities:

1. Every student is responsible for abiding by the regulations in the Student Code of Honor and the General Standards of Conduct as stated in the Student Handbook.
2. Campbell is a residential campus. Unmarried, undergraduate students under the age of 21, who do not live with their parents, must live on campus. Exceptions may include students who have a minimum of 64 credit hours passed, a cumulative GPA of 2.25, and have completed a Request to Move-Off Campus form with all signatures included. If students elect to move off campus after the school year has begun, room refunds will **not** be granted.
3. Rooms may be occupied only by the students to whom they are assigned. Rooms may not be sublet to another person. In order to change rooms, a student must seek approval from the Residence Life Office.
4. Room and facility assignments may be changed or canceled by the University in the interest of order, health, discipline, maximum utilization of facilities, or disaster.
5. The following University personnel may enter student rooms at any time to assure that University policies are being upheld, to inspect, and to make repairs: the Dean of Student Life, Assistant Dean for Campus Life, Men's Campus Coordinator, Women's Campus Coordinator, security officers, Resident Directors, and Resident Assistants.
6. It is the responsibility of each student to respect the rights of others living in University residence halls, regardless of race, creed, or color.
7. Students forfeit their rooms if they do not pick up a key for that room by 5:00pm on the first day of classes, unless the university is notified in advance of extenuating circumstances.
8. Students may not visit or host members of the opposite sex in their residence hall rooms, nor indulge in fornication or homosexual activity.
9. Students are responsible for the safety of their personal property. The University does not guarantee against loss due to the failure of mechanical equipment, interruption of utilities, or against voltage surges in electrical current.
10. The University reserves the right to determine the use of all lounges, common public areas, kitchens, canteens, and laundry rooms in the residence halls.
11. Charges will be made for repairs required due to improper care of the rooms, such as damages to the room, equipment, or furnishings. Additional charges will be added for rooms left unclean. Students are jointly responsible for care of public areas, including kitchens, canteens, and laundry rooms.
12. Campbell University prohibits, on or off campus, the possession or consumption of alcoholic beverages or illegal drugs, in accordance with the Code of Honor and the General Standards of Conduct.
13. Use or possession of guns, firearms, or weapons of any kind is prohibited on campus.
14. The only pets allowed in residence halls are small fish and turtles.

Please sign and return this agreement to the Residence Life Office as soon as possible. Room assignments are made only after a housing deposit is received and a Student Housing Agreement is completed.

Returning students may be released from this agreement by giving notice to the Office of Residence Life by June 1st. Students who cancel after June 1st or fail to occupy their space by the first day of classes will be charged a Late Cancellation Fee.

I have read, understood, and agreed to comply with all the terms, conditions, and responsibilities as stated in this Student Housing Agreement, including but not limited to the payment of any and all applicable fees as set forth in the Student Statement of Charges. I further understand that failure to comply with any conditions, terms, or requirements of this Agreement may result in the immediate termination of my rights to be housed in student housing, and a forfeiture of any fees paid to the date of termination.
